Waiver and release of Liability

In this agreement, the term herein referred to as **“Activity”** or **“Activities”**, includes all activities, events, or services provided, arranged, organized, conducted, hosted, provided, sponsored, or authorized by Prairie Harvest Hockey, herein referred to as **“PHH”**; and specifically includes, without limitation, ice, turf and court based sports, lessons, camps, clinics, tournaments and all other activities, events and services in any way connected with or related to PHH or its rented facilities whether taking place before, during, or following participation in the Activities. The term herein referred to as **“Facility”** or **“Facilities”**, includes all arenas, community centres or specified locations rented or used by PHH for the Activities. The term **“Participant”** means the party, other than PHH, who signs this agreement (or, in the case of a youth, the youth in respect of which a parent or legal guardian has signed this agreement), who shall be bound by the considerations set forth herein.

In consideration with being allowed to participate in any Activity, or an even related to an Activity, held by PHH at the set Facility, the undersigned acknowledges and agrees that:

1. ADULT PARTICIPANTS

The Participant understands and agrees that the Activities being engaged in have physical dangers that may result in serious injury and/or death. The Participant hereby acknowledges that such participation involves risks and hazards incidental there to, all of are expressly assumed and hereby waives, releases, absolves and agrees to indemnify and save harmless PHH, its directors, officers, employees and agents (including, without limitation, any contracted officials, staff, owners, or employees of any premise used by the Activity) of and from any and all actions, causes of actions, complaints, demands and claims whatsoever in existence prior to, on or after the date hereof whether in law or in equity, in respect of death, injury, loss or damage to the Participant or their property howsoever caused, except to the extent that the same are caused directly by the gross negligence of the aforementioned releases. The Participant is advised to retain primary medical insurance benefits prior to participating in any Activity. The Participant certifies that they have no known medical condition that would prohibit them from participating in an Activity.

The Participant agrees to wear the specified equipment set forth on the event requirements, and acknowledges that even with the recommended equipment, they are still at-risk to incur a minor or severe injury, up to and including death as a result of their participation in an Activity. The Participant agrees that they will act in a responsible manner while engaging in any and all Activities. The Participant agrees to reimburse PHH, in full, within five days of notice, for the cost of

any property damage at the Facility for which the Participant is held responsible by PHH. The determination of such reimbursement to any Participant of fees paid to PHH.

The Participant acknowledges that PHH has the final authority and discretion to schedule the Activities and times in which the Participants will participate or play. The Participant understands and agrees that their registration may be suspended or expelled from an Activity, for any of the following, but not limited to:

- Financial delinquency to PHH
- Failure to abide by Activity requirements
- Falsification of registration information

Consent to Filming

I understand and agree that I will not receive any remuneration in connection with the capture or public transmission of my participation in Activities provided by PHH at the Facilities. 2. YOUTH PARTICIPANTS

The Parent hereby acknowledges that such participation involves risks and hazards incidental there to, all of which are expressly assumed and hereby waives, release, absolves and agrees to indemnify and save harmless PHH, its directors, officers, employees and agents (including, without limitation, any contracted officials, staff, owners, or employees of any premise used by the Activity) of and from any and all actions, causes of actions, complaints, demands and claims whatsoever in existence prior to, on or after the date hereof whether in law or in equity, in respect of death, injury, loss or damage to the Participant or their property howsoever caused, except to the extent that the same are caused directly by the gross negligence of the aforementioned releasees. The Parent certifies that the Participant has no known medial condition that would prohibit them from participating in an Activity.

The Parent agrees to cause the Participant to wear the specified equipment set forth in the event requirements, and acknowledges that even with the recommended equipment, the Participant is still at-risk to incur a minor or severe injury, up to and including death as a result of their participation in an Activity. The Parent agrees that the Participant will act in a responsible manner while engaging in any and all Activities. The Parent agrees to reimburse PHH, in full, within five days of notice, for the cost of any property damage for which the Participant is held responsible by PHH at the Facility. The determination of such responsibility shall be binding on the Parent and the

Participant, and the Parent agrees that there shall be no reimbursement to any Parent or Participant of fees paid to PHH.

The Parent acknowledges that PHH has the final authority and discretion to schedule the Activities and times in which the Participants will participate or play. The Parent understands and agrees that the Participants registration may be suspended or expelled from an Activity, for any of the following, but not limited to:

- Financial delinquency to PHH
- Failure to abide by Activity requirements
- Falsification of registration information

Consent to Filming - Minor/Child

Should a PHH representative be unable to obtain my consent for treatment for any medical condition or accident, by my signature below, I authorize a representative of PHH to act on my behalf by contacting our emergency contact names provided and/or by arranging for transportation, by emergency vehicle if necessary, to a hospital or other medial facility. Any doctor, transfer service, or medial facility may rely on this release to administer appropriate treatment or surgery necessary in the opinion of an attending physician.

I will also give permission for first aid trained and qualified Camp staff members to administer first aid treatment to my child and acknowledge that I will be responsible for any medical charges in connection with my child's treatment.
